- 7) That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board for time to time. The School undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- 8) That the School will ensure compliance of all statutory requirements like EPF,ESI and Labour Laws Etc. with respect to the school and staff of the School.

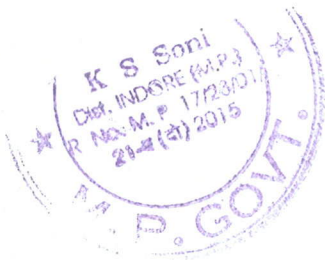
- 14) That the School shall strive to make efforts for conservation of environment.
